
OSMUNDSON MANUFACTURING TO EXPAND FACILITY IN DALLAS COUNTY

Osmundson Manufacturing Co., a fifth-generation family-owned company, designs agricultural disc, coulter, and seeding blades for original equipment manufacturers and distributors worldwide. The company plans to expand its Perry facility by approximately 20,000 square feet to increase manufacturing capacity and employee amenities. The board awarded this \$19 million capital investment project tax benefits through the HQJ program. It is expected to create 17 jobs, of which two are incented at a qualifying wage of \$28.70 per hour.


Osmundson is a clear indicator that our County is open for business and thriving as a hub for innovative and forward-thinking companies.

Prospects By Type - From: 09/01/2022, To: 10/05/2023




Business Prospect - From: 09/01/2022, To: 10/05/2023




PERFORMANCE METRICS

Industry Type - From: 09/01/2022, To: 10/05/2023




Prospect Lead Sources Comparison - From: 09/01/2022, To: 10/05/2023
